



Habitat for Humanity Greater Boston's Terms and Conditions for 2008 Boston Marathon® Charity Program.

Please read the following very carefully, print it out, and sign below.

Please send in the Terms and Conditions along with a \$10 application processing fee and the application itself to the address located below, ATTN: Marathon Selection Committee.

1. Fundraising Commitment: A minimum donation of \$3,000.00 is required to join Habitat Greater Boston's marathon team, the Habitat Hotfooters, and receive an individual entry for the 2008 Boston Marathon. *Preference will be given to applicants who demonstrate an ability to raise more than the minimum amount.*

A non-refundable deposit of \$100 will be charged to your credit card if you are accepted onto the team and you confirm participation. The \$100 will be applied toward your fundraising minimum and holds a Boston Marathon number in your name until January 15, 2008, when the remaining balance is due.

Valid credit card information must be included with your application to apply for Habitat Greater Boston's team. ***In the event that you do not meet the minimum donation requirement by January 15, 2008, Habitat Greater Boston reserves the right to charge the balance owed to your credit card,*** unless prior arrangements have been made. MasterCard and Visa are accepted.

2. Cancellation Policy: You may cancel your participation with Habitat Greater Boston for the Boston Marathon, waiving your responsibility for the \$3,000 minimum anytime on or before December 21, 2007. To do so, you must contact Duncan Ramage-Healey at Habitat Greater Boston, in writing, on or before the cancellation date. Your \$100 deposit is non-refundable. After December 21, 2007, you are responsible for raising the \$3,000 minimum, even if for any reason, including injury, you are unable to run in the Boston Marathon.

Donations raised and received by our office will not be refunded, even if you cancel before December 21, 2007.

3. Matching Gift Policy: Many companies match employees' charitable contributions. You can check with your employer to see if your company has this program, and ask donors if their employers match gifts. Many companies issue matching gift checks quarterly or semi-annually: therefore, if you plan to use a match to reach your minimum, it is your responsibility to contact the matching company to ensure the check will be issued before January 15, 2008. If a company's match cycle is past January 15, 2008, the match cannot count towards your minimum.

4. B.A.A. Registration: Habitat Greater Boston will inform you of the details of the B.A.A. registration after your application is accepted. The B.A.A. charges a \$200 race application fee that does not count towards your fundraising commitment. You will be required to pay for this fee and fill out the appropriate registration application by January 15th when the applications become available (usually around mid-December). You will then mail the registration fee and application to Habitat Greater Boston. *You should NOT mail the materials, or contact the B.A.A. directly, to secure your number.*

5. Release Form and Contribution Agreement: In consideration of my accepting this entry I hereby for myself, my heirs, executors and administrators, waive and release all rights for claims and injuries suffered or sustained by me in said event, in the training and planning sessions for said event, or travel to or from any of the preceding. I further attest and certify that I am physically fit and have sufficiently trained for competition in this event, and a licensed medical doctor has verified my



physical condition. I also grant permission for use of my name and or photography or voice in broadcast, telecast, print or any other account of this event and agree to waive any compensation for such use. I agree to collect a minimum of \$3,000 for Habitat Greater Boston by January 15, 2008. If I have not reached the minimum in sponsorships by that date, I will personally be responsible for the balance owed. I understand that unless I cancel by December 21, 2007, Habitat Greater Boston reserves the right to charge the balance I owe to my credit card after January 15, 2008. I declare that I have exercised my own judgment in signing this agreement and I further declare that the decision to sign this agreement was voluntary and not based on or influenced by any representation of Habitat Greater Boston.

In the event of an illness, injury or medical emergency arising during the event or in the training and planning sessions for said event, I hereby authorize and give my consent to Habitat Greater Boston to secure from an accredited hospital, clinic and/or physician any treatment deemed necessary for my immediate care. I agree that I will be fully responsible for payment or any and all medical services and treatment rendered to me including but not limited to medical transport, medications, treatment, and hospitalization.
